关于上述 4 条问题:在中国内地发生交通意外,将由内地的理赔服 务机构 - 利宝保险有限公司广东分公司处理理赔事宜,且适用中华 人民共和国(不含港、澳、台地区)法律。在内地发生事故后,建 议客户第一时间呈报内地利宝保险公司,如客户已向香港利宝保险 公司申报,香港利宝会转交内地利宝保险公司处理。内地利宝保险 公司会根据不同情况对客户做指引,比如指引报交警等。内地利宝 保险公司 24 小时理赔热线是+86-23-88292016。

Regarding the above 4 points: The traffic accidents that occurred in Mainland China will be handled by the Claims Department of Liberty Insurance Co., Ltd. (Guangdong Branch), and the laws of the People's Republic of China (excluding Hong Kong, Macau and Taiwan) shall apply. It is recommended that the insured should report to Liberty China as soon as possible after the accident occurs in Mainland China. If the insured has reported to Liberty Hong Kong, Liberty Hong Kong will transfer this case to Liberty China for handling, and Liberty China will guide the insured (i.e. report to Police). Liberty China's 24-hour claims hotline is +86-23-88292016.
