This Endorsement will attach to and form part of this Policy and is subject to all terms and conditions of this Policy except as they are specifically modified by this Endorsement. To the extent that any term or condition in this Policy may be inconsistent with this Endorsement, the terms of this Endorsement shall prevail.

This policy will not provide any cover on loss(es) or claim(s) directly or indirectly due to or arising from COVID-19 unless the following criteria are fulfilled before the commencement date of the Period of Insurance.

- 1. the age of the Insured Person(s) must below 70 and is Fully Vaccinated\*; or
- 2. Unvaccinated children age below 12 must travel with Fully Vaccinated\* parents

"Fully Vaccinated" shall mean:

The insured person(s) has fulfilled the vaccination requirement unless they are exempted according to the "Vaccine Pass" as announced by The Government of the Hong Kong Special Administrative Region.
